I, _____ (please print name) of the above address hereby agree to abide by the following conditions which Dogs in Distress has listed below.

1. If for any reason I am unable to keep the dog, I will contact Dogs in Distress. The above dog cannot be euthanised unless prior consultation with Dogs in Distress. The only exception is for a medical emergency and confirmations will be required by the attending vet.

2. Dogs must be spayed/neutered by the guardian if not yet done by the date set out above and must not be bred from. A veterinary certificate stating the required operation was completed must be posted to Dogs in Distress quoting the name and reference number of the dog.
3. The above dog will not be used for experimentations or stage purposes of any kind.
4. To always provide qualified veterinary care and treatment for and injury or illnesses that may arise.
5. Provide a minimum of third party insurance to abide by all the requirements of law relating to dogs.
6. To ensure the above dog has owners name and contact details on collar or disc attached thereto. (micro chipping is also recommended)
7. To notify the local authority, police, and Dogs in Distress immediately, should the above dog go missing or become lost.
8. Agree that the donation is not for the administration, fuel costs, and part donation towards the upkeep and medical care of any present and future dogs which the Dogs in Distress may rescue.
9. The donation to Dogs in Distress is non-refundable should I not wish to keep the dog.
10. I agree and understand that whilst Dogs in Distress gives as much information as possible, they do not always have a complete history of the dog and cannot therefore, guarantee temperament, behaviour, or health of the dog.
11. I agree that I have been made fully aware of all responsibilities, which I freely enter into on the signing of this agreement, for the above dog.
12. I confirm that I am over 18 years of age.
